PRE-INSPECTION OF SITE IS REQUIRED BEFORE THE CITY WILL APPROVE A PERMIT. APPLICATIONS MUST BE SUBMITTED A MINIMUM OF 2 WORKING DAYS PRIOR TO BIN DELIVERY DATE TO ALLOW TIME FOR INSPECTION.

BIN PROVIDER CONDITIONS:

- 1. I hereby declare that each waste bin or roll off to be placed on public property pursuant to the requested permit shall be identified and reflectorized in accordance with the provisions of El Monte Municipal Code Section 8.20.268(C) prior to its being placed on any public property.
2. Waste containers shall not be located in any travel lane of any public street, thoroughfare, alleyway or sidewalk.
3. No trash or rubbish will be allowed to be placed in the street.
4. Waste container must be removed when filled to the bin top. No overflow of the bin is allowed.
5. No permit shall be issued for a period to exceed 14 calendar days.
6. A certificate of insurance evidencing general liability insurance in a combined single limit amount of \$1,000,000 bodily injury/property damage per occurrence and a \$2,000,000 general aggregate must be provided to the City before any bin may be delivered. The City of El Monte must be named as an additional insured by endorsement to the policy. The waste company designated herein hereby agrees to indemnify and hold harmless the City of El Monte from all liability for bodily injury or property damage that may be incurred by the placement of any trash bin on public property pursuant to the requested permit.
7. Noncompliance with any of the abovementioned conditions will require immediate removal of the waste container from the public property by the applicant. If the container is not removed by the applicant as requested, the City shall have the container removed and the applicant will be charged accordingly.

I UNDERSTAND THAT any false or misleading information provided or false declaration made on or in furtherance of this application may result in my being criminally prosecuted in a court of law.
