# **Mandatory Recycling and Organics Waste Diversion**

As part of California's Integrated Plan for Addressing Climate Change, several laws were passed to help reduce greenhouse gases, increase recycling in the U.S., and divert organic materials away from the waste stream. See below for details on each new California State Law and resources to help ensure compliance.

### **AB 341: Commercial Recycling**

The aim of AB 341 is for businesses and other public entities to recycle as much of the waste they generate as possible. AB 341 requires that businesses that generate four (4) cubic yards or more of commercial solid waste per week or are a multifamily residential dwelling of five (5) units or more must now arrange for recycling services. ### **AB 1826: Organic Waste Recycling**

About half of California's waste stream is organic material like yard trimmings, food waste, and lumber. Organic material can be diverted from landfills into composting and anaerobic digestion facilities where it is transformed into rich soil amendments and biofuel. California is aiming to reduce the amount of organic waste by 75 percent by 2025. In order to achieve this target, AB 1826 requires commercial businesses to arrange for organic waste recycling

services if they generate two (2) cubic yards or more of solid waste per week.



All commercial properties are required to determine their AB 1826 compliance status and implement an organics recycling program if eligible. Please note, however, that multifamily dwellings organics recycling is specific to landscape waste only (not food waste).

## **SB 1383: Edible Food Recovery**

In September 2016, Governor Brown Jr. set methane emissions reduction targets for California in a statewide effort to reduce emissions of short-lived climate pollutants (SLCP). The targets must:

- Reduce organic waste disposal 50% by 2020 and 75% by 2025.
- Rescue, for people to eat, at least 20% of currently disposed surplus food by 2025.

Beginning next year on January 1, 2022, California's Short-Lived Climate Pollutants Law (SB 1383) will go into effect and will require property owners, organic waste generators, and commercial edible food generators to implement organic waste collection programs, edible food recovery, and tracking & reporting that comply with the requirements of SB 1383. This will include:

Supermarkets	Wholesale food vendors	Restaurants
<b>Grocery stores</b>	Large venues & events	Health facilities
Hotels	Food service providers	Food distributors

SB 1383 requires businesses to donate the maximum amount of edible food they would otherwise dispose to food recovery organizations. Los Angeles Regional Food Bank and Food Finders are great organizations that partner with local businesses and will distribute donated food to people in need.
