Organic Waste Recycling & Surplus Food Recovery

Businesses and consumers in California toss nearly 6 million tons of food annually, according to the California Department of Food and Agriculture. When all that food gets dumped into landfills, it turns into methane, a greenhouse gas dozens of times more damaging to the climate than carbon dioxide. To help save the planet and feed more people, the state of California, along with hunger relief groups, are trying to find better ways to rescue and recycle (often perfectly edible) food before it's trashed.

California recently passed a series of legislation after setting State goals to reduce the disposal of organic waste by 75% by the year 2025 and to recover 20% of commercial edible food from the waste stream.



A closer look at the State mandates:

AB 827 - Requires recycling and organic waste bins to be easily visible and accessible to customers and staff disposing of food waste at restaurants and other food establishments.





AB 1826 – Requires businesses who generate two-cubic yards or more of solid waste per week to arrange for the collection and recycling of organic waste.

SB 1383 – Expands the requirements for organic waste recycling to all jurisdictions, including residential and multi-family properties, to sort and recycle their food waste. In addition, all commercial edible food, which is any unsold or served food that is fit for human consumption, even though the food may not be readily marketable due to appearance, age, freshness, grade, size, surplus or other conditions, must be diverted into programs that feed people facing food insecurity.

Too Toxic to Trash

Household Hazardous Waste, or HHW, is any product labeled: toxic, poison, combustible, corrosive, flammable or irritant that is disposed of. Valley Vista Services does NOT collect Household Hazardous Waste.

Examples of hazardous waste include:

Antifreeze • Abrasive Cleaners • All Batteries

Motor Oil • Transmission Fluid • Paint

Pesticides • Prescription Drugs

Sharps/Syringes/Lancets • Solvents

Report Illegal Dumping

In order to ensure proper pickup, all trash and recycling

bin lids must be closed completely. If bins are overfilled or have bulky items preventing the lid from closing properly, there is a risk of having items fall out during the dumping process. The bin may be tagged for safety reasons. To report illegal dumping happening in your



trash bin or anywhere else in the City of Industry, go to *CityofIndustry.org/How-Do-I/Report-an-Issue* or download the city issue-reporting app called *SeeClickFix*. SeeClickFix is a mobile application that allows citizens to report non-emergency related issues to the City.

All issues submitted will go directly into the City's issue tracking system. App users can input descriptions, GPS-specific location, as well as photos of the issue. Once a request is submitted, you can keep track of pending and completed requests, as well as view issues that have been submitted by other citizens and track their status. Download the SeeClickFix app today on the App Store or on Google Play to report issues happening in your neighborhood.
